REQUIREMENTS TO THE ABSTRACTS

A collection of abstracts is planned for the International Scientific and Practical Conference, which will be published in electronic format on the website of the Educational and Scientific Institute of Public Administration and Civil Service of Taras Shevchenko National University of Kyiv.

To participate in the conference, it is necessary to complete *online* registration <https://forms.gle/WYfHAqJnBa4fToky6> by **April 29, 2025** and send materials to the e-mail address konf_ipacs@ukr.net by **May 6, 2025**

In the subject of the e-mail, it is *necessary* to indicate the surname of the speaker and the name of the section under which the materials are submitted (for example: Cherniashchuk_EU values and innovations for the transformation of Ukrainian society). The file name of the materials must match the author's last name (for example: Cherniashchuk).

Publication of participants' theses *is free*.

Be sure to check your email address for a letter from the organizing committee confirming receipt of your materials. If there is no confirmation, please send the materials again within a week from the date of the first submission (no earlier than two days later).

Materials are submitted in the form of abstracts without appendices and footnotes (3-5 pages), typed in the MS Word text editor, font – Times New Roman, size – 14, line spacing – 1.5; margins – 20 mm, paragraph indentation 1.25 cm.

Abstract structure:

- UDC index;
 - name and surname of the author, position, place of work (in Ukrainian and English);
 - ORCID ID of the author (if available);
- (for applicants) name, surname, academic degree, academic title, position, place of work of the scientific supervisor (in Ukrainian);
- title of the abstract in capital letters in the middle (in Ukrainian and English);
 - for abstracts in Ukrainian, a summary in English (100 words), Keywords: 3-5 (do not repeat words in the abstract title);
 - for abstracts in English, a summary in Ukrainian (100 words), Keywords: 3-5 (do not repeat words in the abstract title);
 - main text;
 - list of sources used, drawn up in accordance with the requirements of DSTU 8302:2015 “Information and documentation. Bibliographic references. General requirements”.

Submitted abstracts will be reviewed. We draw the authors' attention to the principles of academic integrity.

The Organizing Committee for the Conference reserves the right to reject abstracts that do not meet the conference theme or format requirements.
